THESE ARE CHILDREN (AGE 10 TO 14) WHO LIVE IN ORPHANAGES AND FOSTER CARE, AND HAVE LITTLE OR NO CHANCE OF FINDING ADOPTIVE PARENTS IN THEIR OWN COUNTRIES.
